 - 59,545 unique individuals
 - in the STATES Data obtained via FOIA request


- Data includes:


Enrollment patterns: international enrollment in law school and in all fields/levels, 2012-2021


Total international students all fields/levels*



Newly-enrolled students per year, by program








Sending country detail: JD (vertical axis) and Master's+ (horizontal axis), all years aggregated $(\log_2 2 \text{ scale})$




Sending country detail: linear scale degree program and home country, all years aggregated















Gender

Females per male by degree program, by year




% of males and females in Top20 v. non-Top20 law schools, all programs, by year
