- 143 residency
- 65 online
- 54 residency + online

All non-JD enrollment

- **19,819 non-JD enrollment**
- **15%** law school enrollment
- 500 programs avg. 40
- **151 schools 131 avg (125)**

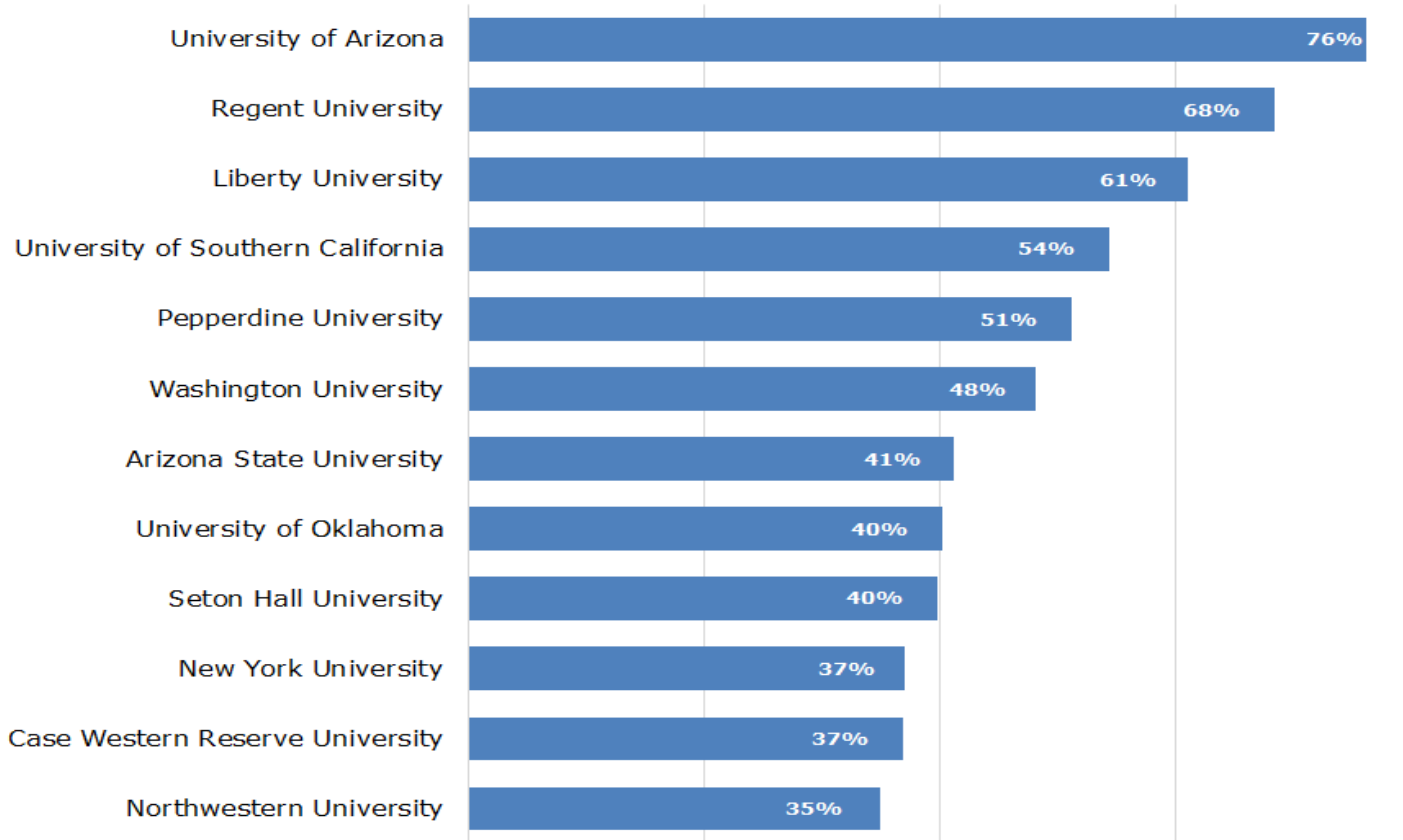

- 143 schools
- 12,441 resident enrollment
- **87 avg**

Non-JD Residential Data

- 20 schools > 200
- 6,005 enrollment (45%)
- **300 avg**
- **52 avg for remaining 123**

Online Non-JD

- 7,378 online in 65 programs
- **114 enrolled avg**
- **10 largest > 271 (= 3,624)**
- **remainder avg 68**

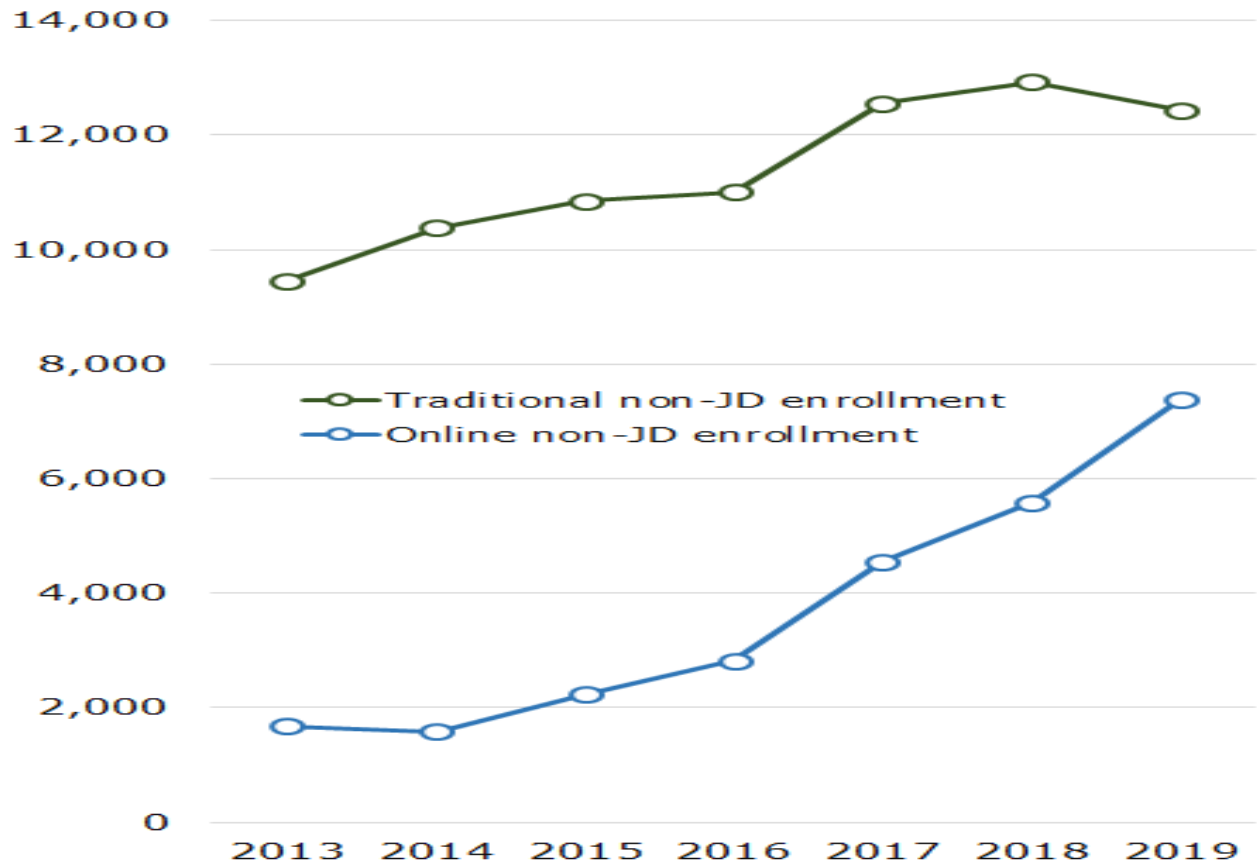

- **56% in state**

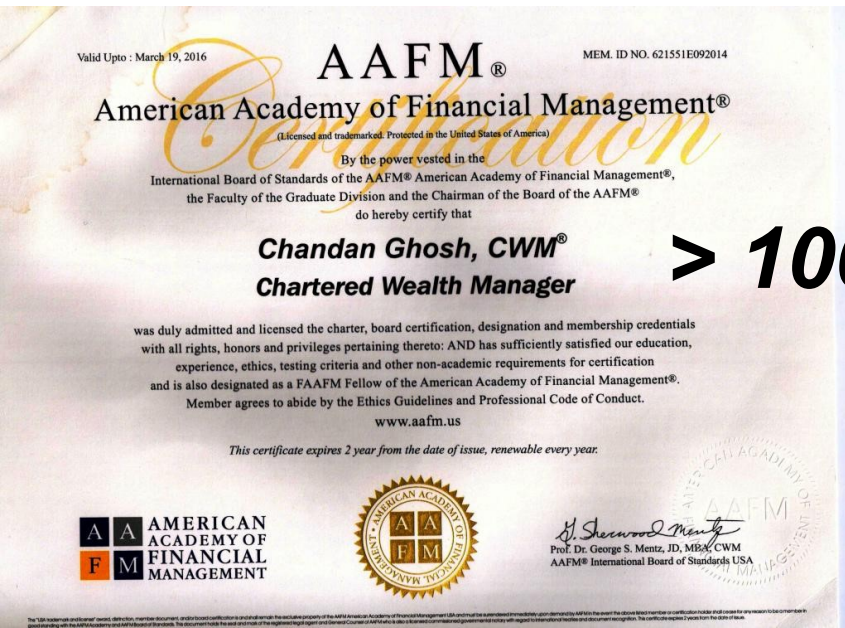

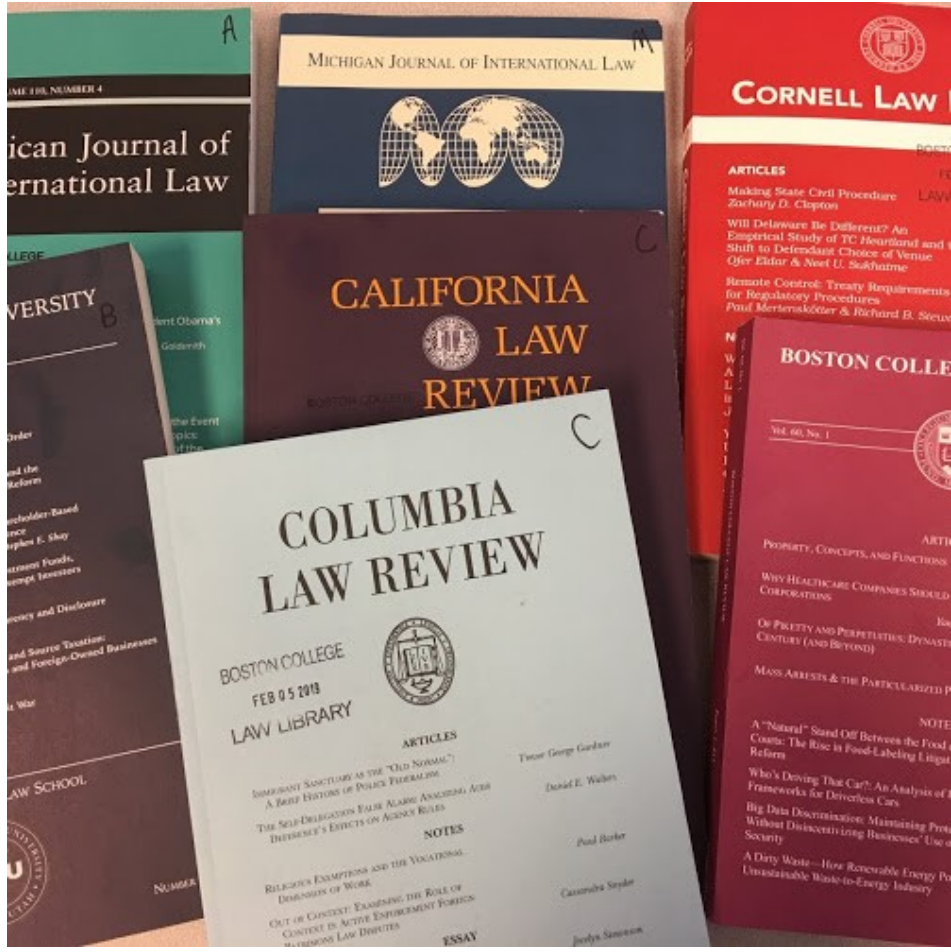

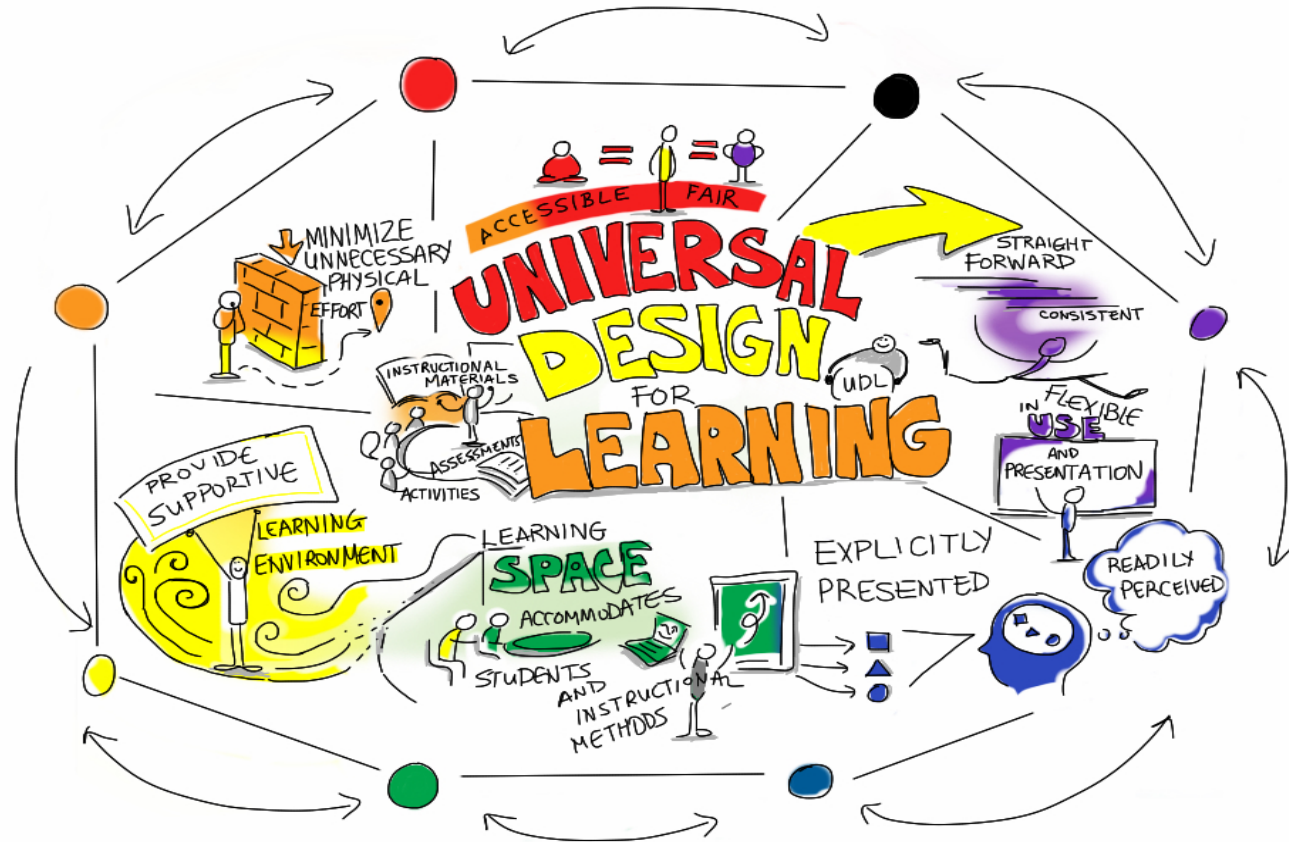
